Affordable Care Act Requirements Summary

The Affordable Care Act (ACA) introduced significant changes in healthcare regulations for employers, requiring meticulous recordkeeping and reporting. This one-page overview will help you understand the key requirements and obligations imposed on employers under the ACA.

1. Employee Eligibility and Classification

- Maintain records of employee classifications (full-time, part-time, variable hour, seasonal, etc.)
- Track and document changes in employee status that impact ACA compliance.

2. Employee Health Coverage

- Keep records of health coverage offers and elections.
- Document the coverage waiting periods provided to employees.

3. Forms 1094-B/C and 1095-B/C

- Employers subject to the ACA's employer mandate must use Form 1095-B/C to provide full-time and covered employees evidence of their health coverage or offer of health coverage.
- Employers subject to the ACA's employer mandate must use Form 1094-B/C to report information to the IRS.
- The IRS uses this information to determine if the employer is subject to penalties for failing to offer affordable and minimum essential coverage.

4. Documentation of Coverage

- Maintain records of the coverage information submitted on Forms 1094-B/C and 1095-B/C.
- Retain these records for the required period.

5. Measurement, Administrative, and Stability Periods

- Employers using the look-back measurement method must maintain records of hours worked and eligibility determinations for measurement, administrative and stability periods.

6. Reporting to Employees

- Furnish copies of Form 1095-B/C to employees, reflecting the information submitted to the IRS.

7. Record Retention

- Keep all records related to ACA compliance for a minimum of three years from the filing due date or the date of filing (whichever is later).

8. Compliance Audits

- Furnish copies of Form 1095-B/C to employees, reflecting the information submitted to the IRS.

9. Large Employers (Applicable Larger Employers)

- Employers with 50 or more full-time equivalent employees are considered applicable large employers and are subject to the employer mandate.

10. Penalties for Non-Compliance

- Failure to comply with ACA requirements may result in penalties.
- Penalties can be assessed for failure to offer coverage or for offering unaffordable or inadequate coverage.
